Publisher's Note

Officially authorised by the London Stock Exchange, this microfilm edition makes available a complete run of the *Stock Exchange Year-book* (renamed the *Stock Exchange Official Year-book* in 1909) for the period 1875 – 1945. It includes a copy of the extremely rare first volume (not held by the London Stock Exchange or Guildhall Libraries) and due to the choice of the Comic (2A) filming format and the use of a low reduction (8x – 10x) these densely packed volumes are easy to read and will produce clear printouts. In consequence this microfilm edition makes more reels that rival editions, even though it is sold for the same price.

The London Stock Exchange was at the centre of the world's financial and trading markets from 1875-1945. It was *the* place to raise capital and almost every country in the world featured in its lists of government securities and company stocks. The strength of the British economy in the period and the international spread of the British Empire contributed to its importance.

The Stock Exchange Year-book started in 1875 and quickly grew in size and stature, eclipsing rival publications. Its readers acknowledged it as an essential reference source for tracking the growth and the development of individual companies, international markets and the economy as a whole.

Today, it is acknowledged as a basic reference source for economic and business historians, but one for which most libraries only hold scattered issues. Even where volumes are held these are often in a poor state of repair due to the fragility of the paper and bindings and the heavy usage of such unwieldy volumes over time.

We can now offer a complete 70 year run of the Year-Book from 1875 to 1945, tracing the development of British Commonwealth and World finance and industry from the heights of the Victorian era to the end of the Second World War.

Every issue is packed with detail and is extensively indexed. They are large volumes. In the preface to Volume 2 for 1876 it is stated that "it is the object of the STOCK EXCHANGE YEAR-BOOK to give an account of every public company and security known in this country."

Furthermore, to provide "a careful digest of information relating to the origin, history, and present position of each of the Joint Stock Companies and Public Securities known to the markets of the United Kingdom." The volume then proceeds with an index to c1400 companies featured ranging from Aberdeen Jute through Baltic Iron Ship Building, Direct United States Cable, Lady Well Mining and Scottish Widows' Fund and Life, to the Zealand Railway.

The volume then lists:

- Government Securities Home, Colonial & Foreign (including: Bolivia; China; Columbia; Denmark; Egypt; India; Jamaica; Japan; Louisiana; NSW; New Zealand; Quebec; Russia; Santa Fe; Tasmania; Victoria; and Virginia. Of Arkansas it notes: "this state, happily little known to European investors, appeared in this market in March 1872.")
- Railways (including: Antwerp and Rotterdam Railway Co; Baltimore & Potomac Railroad Co; Bolivar Railway Co; East Bengal Railway Co; Great Western Railway; Royal Swedish Railway Co; Union Pacific Railroad Co.)
- Banks (including: Anglo-Austrian; Bank of England; Bank of South Australia; Lloyds Banking Co; Midland Banking Co established in 1863; Yorkshire Banking Co)
- Insurance (including: Alliance; British & Foreign Life & Fire Insurance Co; Legal and General Life Assurance Co founded in 1836)
- Tramways, Telegraphs, Gas and Water, Mines, Steamships, and Trusts, Miscellaneous Bonds
- Miscellaneous Companies (including: Artisans' Labourers' & General Dwellings Co Ltd; British American Land Co;
 Darlaston Steel & Iron Co Ltd; Hudsons' Bay Co; Asiatic & American Co Ltd; London Tavern Co Ltd; River Plate
 Pressure Meat Preserving Co Ltd; Worcester & Birmingham Canal Co)

For each company the volume gives lists of Directors, dates of establishment, capital value and the amount paid up or subscribed, details of trading, dividends and dates of meetings.

Subsequent volumes follow the same general format, but new categories are included and the list of companies covered expands dramatically. By 1886 there are close to 3,400 companies listed. By 1906 this grows to 7,200; by 1926 it reaches 15,000; and by 1936 it reaches 27,600 companies.

In later volumes specific listings are given of: Lighting & Water Companies; Mining Companies, Iron; Coal and Steel Companies; Land Investment Finance & Discount Companies; Rolling Stock Companies; Tea, Coffee and Tobacco Plantation Companies; Hotel, Brewery and Distillery Companies; Dock, Canal and Harbour and Shipping Companies; Oil Companies.

Further invaluable data added concerns; Reviews of the Year; Statistical Analysis of the growth of commerce; Notes on Stamp Duties and Bank of England Rates of Discount since 1871; Lists of Trustees and Managers of the Stock Exchange; Lists of Brokers; Company Law; Municipal Finance; and much more.

PREFACE.

The object of the STOCK EXCHANGE YEAR-BOOK AND DIARY is to provide a reliable and inexpensive digest of information relating to Public Securities and Joint-Stock Companies. It is believed that no attempt has ever been made to give a descriptive account (as contrasted with the inelastic tabular compilations) of all sections of this vast and rapidly increasing subject, and from the present magnitude of this form of investment and its certain continued development, such a work considered likely to be of public usefulness.

It will give some idea of the amount of the securities known to the markets of the United Kingdom, to state that the following pages give the necessary and ascertainable details relating to investments representing no less a sum than £4,459,459,128. This total is made as follows:-

It is, of course, not to be assumed that this amount is exclusively held in the United Kingdom. Of Government Securities, quite two-thirds are common to most European markets, and one half the whole is probably the extent of the actual proportion held in this country. There is also a deduction to be made from railways. Of the amount given above under this head, nearly a half belongs to home undertakings; and of the remainder, a large portion is composed of mortgages and other issues, exclusively held in this market in respect of foreign and colonial lines, but the amount of railway securities really belonging to British investors does not probably exceed £750,000,000. Of the remaining £313,414,972, no appreciable amount is held abroad. It may, therefore, be assumed that the following fairly represents the distribution of the securities known in this country:-

The sole claim to usefulness of such a work as the STOCK EXCHANGE YEAR-BOOK AND DIARY is the correctness of its statements; and no pains have been spared to secure this all-important consideration. Wherever possible, I have worked back to the origin of both loans and companies, and striven to give an account of the foundation and history, as well as of the present position, of each security. Further, all statements as regards companies, which are necessarily of a more varied and less easily ascertainable experience than public loans, have been verified by submitting proofs to the companies. It is only becoming to here acknowledge the great assistance derived from the use of

prospectuses and other documents anterior to my own accumulations, and from the readiness with which the companies and agents have revised the statements of facts, and added many interesting and not otherwise obtainable details, without, as a rule, desiring to re-model my conclusions. This is the more to be appreciated because, from the first conception of the task, it was seen to be absolutely necessary to fairly recite all circumstances that would assist the investor to arrive at a sound judgement. It has naturally been difficult, in the case of some recent companies, to speak without asperity; but in every case where it has been shown that this or that compensating detail has been overlooked, it has been gladly taken into consideration.

The treatment of such a large subject in so small a compass as the plan of this work involved, has necessitated the rigid exclusion of all but the most material information. The plan pursued has been, as regards companies, to give – the title; the directors, as being responsible for the management; the secretary, or other officer, with whom all correspondence should take place; the address of the company; particulars as to the capital, including the liability in respect of the shares of chartered and unlimited companies, both as regards existing and past holders; the amount of the transfer fee; in what markets the shares are chiefly dealt in; when and where the meetings take place; when the dividends are paid; and other general information arising out of the experience of each undertaking. It has been suggested that it would have been well to have included the name of managers, or other officers, upon whom sometimes even more depends than upon the directors; and preparing future issues of the work this and other suggestions will be borne in mind.

With regard to Government and other Loans, it has been sought to give an estimate of the antecedents, position and prospects of each borrower, as well as the various details as to the amount of the original issue, the amount outstanding, and the amount of the bonds; when, where, and how the coupons are paid, and the bonds redeemed; and all other information considered likely to aid the judgement of investors.

The Calendar has been especially prepared for the use of Stockbrokers and others concerned in market operations, with the view of affording the information experience has proved to be necessary without the labour independent inquiry or memoranda.

PREFACE TO 1895 EDITION, OUTLINE OF CONTENTS & INDEX TO COMPANIES LISTED IN 1895

By 1895 the **Stock Exchange Official Yearbook** had settled into a format that it was to stay with for the duration. We reproduce the Preface, Outline of Contents and the Index to companies listed in 1895 to give readers an idea of the typical organisation of a yearbook, and of the great variety of companies covered in this and in future volumes.

PREFACE.

The year 1894 has not proved so favourable to business as was expected. This is chiefly due to the further considerable decline in the prices of natural products, and to some extent to the difficulty in bringing to a conclusion the tariff and other reforms in the United States to which President Cleveland had put his hand. But the year closes with a nearly complete absence of disturbing causes, though the prices of produce are still at their lowest, and the return to commercial and agricultural prosperity is in all parts of the world proceeding at an abnormally slow rate. But it is generally admitted that the worst is now more than over. This is an immense gain in itself, especially as regards Stock Exchange securities, amongst which selling from fear or necessity no sooner ceases than an upward movement on some scale sets in.

A year ago we had to report a further considerable fall in the aggregate of Stock Exchange values; but for 1894 there has been a rise in prices which more than outsets the decline then reported, and to all appearance the upward movement is still in progress. Moreover, the ascending tendency is widespread. Almost every class of security is participating in it. High-class investments, such as the National and Municipal issues, high as they were a year ago, have risen considerably – as much as 4 and 5 per cent, being quite common. Foreign government securities of the second and third class have much more advanced, Chilean being as much as 10 up, and Brazilian 15 to 20. The rise in British Railway stocks is also important. The same has to be said of Indian railways, but Colonial railways have had an unfavourable record, while in the American railway section there have been important movements both ways. Atchison and some other large properties having found yet lower levels of degradation, at the same time that good properties have yet further advanced. South American railways have in most instances improved – in some cases considerably. In the various other sections the movements have been numerous and considerable, and a large proportion of them have been favourable.

The formation of joint-stock companies under the Acts of the United Kingdom has proceeded on a somewhat larger scale than was experienced last year, the one conspicuous feature being the great number of West Australian mining companies.

For ten years up to and inclusive of 1893 the record was as follows:-

SAMPLE ENTRIES

Entries in the **Stock Entries Official Yearbook** vary in extent and detail. The following examples are taken from the *Government & Municipal Securities, Railways, Mining, Exploration & Smelting Companies, Banks* and *Land, Investment, Trust, Finance & Discount Companies* sections of the 1895 yearbook. These are to provide readers with an idea of the typical range of information given concerning any individual company. Of course, it is by following the entries for a particular company or companies over a number of years that one can best build up an economic profile of years that one can best build up an economic profile of a company set in its contemporary competitive background.
